* This list results from a search of *The Globe* newspaper using the search term "Clarkson" and examining each entry. For periods in which there were a dearth of ads, a secondary search was performed using the term "Insolvent" and the results were spot checked, with several more clients identified. Clients in 1867 were augmented by those reported in the *Lower Canada Law Journal* prior to Confederation and the *Canada Law Journal* after. Because of a complete absence of ads in *The Globe* between Sept. 17 1870 and November 14, 1871, the list of clients was manually double-checked against *The Daily Leader*. Clients in late 1871 were augmented by lists of insolvents with their corresponding official assignees which were published in *The Globe* in the latter part of 1871. The final ad (in *The Daily Leader*) was identified through a manual search.
